Survey Method

In January 2007, the South Dakota Criminal Statistics Analysis Center (SAC) surveyed sheriff offices in the State. A survey questionnaire accompanied by a cover letter was sent to all sheriff offices.

This was the 12th time the SAC compiled statewide management data pertaining to South Dakota sheriff offices. The results of this survey are intended to provide sheriffs with a valid means of comparing expenditures and resources of offices across the State. In addition, the results should provide the sheriffs with a substantial basis from which to justify future managerial decisions.

Currently, there are 66 sheriff offices in South Dakota (this figure does not include tribal agencies). Fifty-six offices returned surveys yielding a total response rate of 85%.

The survey instrument is a self-report completed by the sheriff or office staff. All questions were designed to be objective; however, some questions may have been subject to different interpretations. Thus, this report can only reflect summary results that are as valid and accurate as the data provided by each office.

It should also be noted that salary data throughout this report are approximations. Due to the number of personnel at any given rank and the diverse salaries relative to each officer, such approximations were necessary in order to perform overall summary calculations.

The completed questionnaires were encoded and verified by the South Dakota Criminal Statistics Analysis Center staff. General

The responding offices are arranged in ascending order by county population. This method of presentation allows the offices to make comparisons with other counties of similar size. Population estimates for 2006 are provided by the F.B.I. These estimates are derived using the most current data available from The U.S. Census Bureau. The counties are broken down by population as follows:

Nine sheriff offices are the only entity housed within their building while 47 sheriff offices are housed with other offices, agencies, etc.

Of the 47 offices that are housed with others, 14 sheriff offices share personnel with the other entities housed within their building; 33 do not share personnel.

When asked if their office shares equipment with other entities housed within their building, 33 sheriff offices said yes; 14 do not share equipment.

Budget

The survey asked to specify the budgeted sources of income for 2007. The total income available to the responding agencies ranged from a low of \$64,275 per year to a high of \$7,171,301 per year. *Note: This does not include the Jail Budget (\$26,993,088) listed on page 27 for offices that have a completely distinct budget for their jails.*

Per Capita Cost of Law Enforcement

The 56 reporting sheriff offices serve counties ranging in size from 1,227 to 161,322 people. The combined total population of these jurisdictions is 734,156. By dividing the budget total expenses for all responding agencies, \$33,422,714, by the combined population of 734,156, a per capita cost of county law enforcement services of \$45.53 is obtained. The per capita cost ranged from a low of \$31.08 for the population grouping 10,000 to 19,999 to a high of \$106.19 for the population grouping of under 2,000.

Separating the counties into their population groupings, the budget breakdown and costs per capita can be further analyzed:

Officer Salaries

The Sheriff’s salary schedule is set by SDCL 7-12-15. The statute states: “The salary payable to a sheriff shall be established by each board of county commissioners, by resolution, but may not be less than specified in the following schedule based upon the most recent decennial federal census of population of counties. The board of county commissioners may not decrease the salary of the sheriff during the term of office of the sheriff. Any sheriff having responsibility for managing a full-time jail shall receive an additional ten percent added to the base salary listed in this section.”

The Sheriffs were asked how the wages/salaries of the sworn officers (other than themselves) in their offices are determined. Thirty-four of the responding offices (61%) indicated the salaries were established at the discretion of County Commissioners. Thirteen (23%) of the offices reported that a salary schedule or policy is in effect. Three (5%) offices reported that salaries are determined by Union Contract, one (2%) by Law Enforcement Board, and five (9%) offices did not report.

Sixty-two (17%) of the full-time, sworn county law enforcement officers in South Dakota are from 35-39 years old. For the 362 officers reported by offices, the gender breakdown is: 335 (93%) male and 27 (7%) female.

Education

Since October 1, 1971, the Law Enforcement Standard and Training Commission requires a high school diploma, or the equivalent (GED), before any officer may be enrolled in the Basic Training Course. This course is necessary for certification as a law enforcement officer. Individual offices may have further minimum requirements for education to get hired or to achieve specific ranks within their particular agency.

The following table depicts the highest level of education attained by the full-time, sworn personnel.

Fifty-four offices (96%) of those surveyed offer a retirement program to their sworn officers. Forty-eight offices (86%) furnish uniforms or provide a uniform cash allowance and 47 offices (84%) furnish basic equipment to their officers.

Personnel Benefits

Education

Nine (16%) of the 56 responding offices provide tuition assistance for employees, 47 (84%) offices do not. None of the offices that do not provide tuition assistance are considering instituting a program that would provide tuition assistance to their employees.

Insurance

South Dakota sheriff offices provide a wide variety of insurance plans for officers and their families. Many offices pay for these plans in full or in part, thereby reducing the financial burden on each officer.

Fifty-five offices (98%) pay partial or full health insurance premiums for their officers. The following table illustrates the types of insurance available to the officer and his/her family and the level of premium paid by the office:

Vacation

The survey results have demonstrated great variation among the offices in vacation allotments, sick leave, and the number of paid holidays offered officers. Below is a table showing the method of accumulation for vacation time and number of agencies that utilize each method:

Sick Leave

Forty-eight offices (86%) have a sick leave policy; eight offices (14%) have no sick leave policy. The amount of sick leave hours that can be earned varies from 40 to 480 hours per year. The most common policy, 25 offices, earn up to 96 hours per year.

Twenty-nine offices (52%) pay a portion of unused sick time to employees when they retire. The amount that is paid back varies widely, from a range of 38 to 1,440 hours or a range of 10% to 50% of the sick leave balance.

Four offices pay a wellness benefit for unused sick time each year.

Thirty-two offices (57%) pay and/or compensate their line officers for overtime. Fifteen offices (27%) pay and/or compensate their supervisory officers for overtime. Thirty offices (54%) pay overtime, 28 offices (50%) pay at the rate of time and one-half, and two (4%) pay straight time.

Second Job

Fifty offices (89%) permit their officers to work a second job; six offices (11%) do not. The following table demonstrates the limitations, if any, placed on sworn officers who routinely work second jobs (an office may list more than one type of limitation):

Vehicles

Fifty-five offices (98%) reported a total of 445 vehicles. There are video cameras in 258 (58%) of these vehicles. Cars (49%) and SUVs (42%) make up the majority of the vehicles. Other vehicle categories which include 4x4 pickup, motorcycle, hummer, boat, bus, and van, account for 9% of total vehicles. One office did not report.

Fifteen of the 56 responding offices (27%) replace vehicles based on both age and mileage. Fourteen offices (25%) replace vehicles per Commissioner's discretion; six offices (11%) replace vehicles based on mileage; and four offices (7%) replaces vehicles based on age. One office (2%) uses another policy for replacing vehicles. Sixteen offices (29%) indicated that they had no schedule or policy for replacing vehicles.

Twenty-two offices (39%) report that the duty weapon can be used only on duty. Of the twenty-eight offices (50%) that allow a backup weapon to be carried, 9 offices allow any caliber. Eight offices allow any caliber of off-duty weapons.



Shotguns

Fifty-two offices (93%) report issuing a total of 322 shotguns. Thirty-five counties (63%) carry both shotguns and rifles in their vehicles, 15 (27%) carry shotguns, and four (7%) carry rifles.

Contract Law Enforcement

A section of the survey was devoted to sheriff offices providing law enforcement services to municipalities in their jurisdictions. Fifty-two (93%) of the 56 responding sheriff offices reported a total of 256 municipalities located within their counties. Thirty-two of these offices have a contract to provide law enforcement services to at least one of the municipalities in their county. Eleven sheriffs, including Aurora County, Beadle County, Campbell County, Edmunds County, Fall River County, Harding County, Jerauld County, Marshall County, Miner County, Spink County, and Ziebach County, indicated that their offices provide contract law enforcement services for all of the incorporated areas within their jurisdictions.

Eight offices are paid based on an hourly rate with a range of \$17.50 to \$29.22. Ten offices are paid based on an annual rate, with a range of \$6,450 to \$123,000. One office is paid based on the per capita rate of \$61.68. Nine offices are paid based on various per city rates. Two offices reported “other” for the method of payment. Two offices did not respond as to how they are paid.

All of the 32 offices provide year-round contract services. The number of hours per month spent by these offices providing services to municipalities range from 50 hours to 1,476 hours.

Nine offices (16%) have a contract to provide law enforcement services for federal agencies. Five of these patrol federally owned property, three provide jail administration and one office provided housing in jail. Six of the offices provide this service year round and three offices provide it seasonally. The hours per month for year round law enforcement services range from 20 hours to round-the-clock.

Cities Not Under Contract

Forty-seven offices (84%) report that a collective total of 161 cities of less than 1,000 population are not under contract with the sheriff's office. Several of those cities not under contract with the sheriff's office have on-call protection, police departments, and/or routine patrol.

Warrants

Fifty offices served 34,990 warrants and fifty offices received 40,657 warrants. As of January 1, 2007, fifty-three offices reported a total of 50,969 warrants pending from prior years.

Forty-one offices served 2,354 out-of-county warrants and forty-three received 2,794 out-of-county warrants. Twenty-four offices spent a total of \$149,619 in extradition costs, averaging \$6,234 per office.

Many offices have full-time and part-time dedicated positions to the processing of warrants. Of the responding offices, 45 offices have 123 full-time officers and 14 offices have 30 part-time officers. Fifteen offices have 22 full-time civilians and eight offices have 12 part-time civilians.

Civil Process

Fifty-five sheriff offices served a combined total of 68,769 civil papers in 2006. Fifty-two offices collected \$723,499 in civil fees that were turned over to the County Treasurers. Forty-five offices reported collection of \$148,819 for mileage fees that were related to the civil process. Seven counties (Beadle, Codington, Davison, Fall River, Hand, Pennington, and Turner) have constables to aid in the civil process.

Some counties do not record their civil process activities. Therefore, the statistics presented here should not be viewed as comprehensive totals for statewide civil process procedures. These totals are lower than the actual statewide totals would be.

Most of the sheriff offices keep track of the degree of satisfaction for executions served based on the amount of fees returned to the County Treasurer. Fifty-three offices returned 5,363 executions in 2006, with 45 reporting a total dollar value of \$3,447,291. Forty-nine offices reported 745 executions were returned fully satisfied. Thirty-nine offices reported 470 executions were returned partially satisfied, fifty-one reported 3,450 were returned unsatisfied, and thirty-eight offices reported 444 executions were still pending. Nineteen offices reported 254 executions that received no action (i.e., aid to garnishment, etc.). These 254 were included in the 5,363 total executions sum.

The degree of satisfaction should not be seen as a reflection on the quality of work done by the specific sheriff offices. Many factors are involved in whether an execution is satisfied or not, and these factors will vary among jurisdictions. One such factor includes executions that receive no action because they are in aid of garnishment.

Thirty-six offices reported collecting a total of \$762,761 in delinquent taxes. Property taxes collected for the local county total \$62,611. Mobile home taxes collected for the local county total \$478,535. Sales and unemployment taxes collected for the state totaled \$195,494. Twelve counties were unable to break down \$26,121 in delinquent taxes. This amount is included in the \$762,761 total delinquent taxes sum.

Sheriff Dogs (K-9)

Ten sheriff offices (18%) reported owning a total of ten dogs. Nine offices reported that the dogs are primarily used for drug detection work, while one reported that the dog is primarily used for patrol work. Two dogs have been used for search and rescue.

Forty-eight offices (86%) have access to a canine from another agency. One office is planning to purchase a dog within the next two years.

Computers

The following table breaks down the desktop computers collectively owned by the 56 responding sheriff offices. All fifty-six offices own computers, but only fifty-four (96%) have internet access.

County Jails

Jail Facilities Out-Of-County

Thirty-two (57%) of the counties responding to the survey have a formal contract with another jurisdiction to house prisoners. One county did not report a formal contract. Two of these counties also operate their own jail facility.

The following statistics vary in that some facilities did not track some of the specific statistics. Seven did not report total fees, six did not report total prisoners, and seven did not track their mileage.

There were a total of 2,881 prisoners reported housed in another county's jail facility. Of these total prisoners, 2,844 were reported by counties without jail facilities, while 37 of these prisoners were reported by the two counties that operate their own jail facility. The number of prisoners taken to another county's jail facility ranged from two prisoners in one county to 1,129 prisoners in another county.

The responding sheriff offices traveled over 144,252 miles transporting prisoners. Of these total miles, 140,972 were reported by counties without jail facilities, while 3,280 of these miles were reported by the two counties that operate their own jail facility. The jail fee paid for each prisoner per day ranged from \$45 to \$70. Ten counties paid \$45 per prisoner per day, and ten counties paid \$50 per prisoner per day. The total reported dollar amount spent by responding offices in 2006 for jail fees to other jurisdictions was \$1,155,530. Of this total, \$1,112,486 was reported by counties without jail facilities, while \$43,044 of this was reported by the two counties that operate their own jail facility.

Jail Facilities In-County

Twenty-five (45%) of the counties responding to the survey operate a jail facility. Thirteen (52%) of these facilities are classified as Regional Jail Centers; that is, they house prisoners from other jurisdictions as well as from their own. Another nine (36%) have Full Jail Facilities and are able to house their own prisoners for extended periods of time (longer than 72 hours). Three (12%) of the 25 counties have Limited Holding Facilities which are limited to housing prisoners for less than 72 hours. After 72 hours of being incarcerated, the prisoners in the Limited Holding Facilities must be transported to a Regional Jail Center in a neighboring jurisdiction.

Of the 25 counties that have a jail facility, nine (36%) of them have a contract with the U.S. Marshal's Office to board federal prisoners.

Jail Budget

Twenty-five offices reported a combined jail budget total of \$26,993,088. Not all offices reported all budgeted items. The jail budgets are further analyzed for each county in detailed tables located in the back of this section. The authorized salary range (low to high) for the correctional officers is \$4,033 to \$52,248. The combined jail budget by category for reporting offices is as follows:

When reviewing the jail budget data, it is important to realize that some offices have completely distinct budgets for their jails, separate from their office budget. Other counties cannot separate jail costs from their total budget. In these counties, it is difficult to distinguish the expenses incurred for jail personnel from the office personnel costs, and the jail operations expenses from the office expenses, etc. Budget comparisons among these counties are difficult.



Jail Personnel

The responding 24 counties report a total of 527 employees involved in the operation of the jail facilities. One county did not report its jail personnel. Eighty-one percent (429) of these are full-time employees, with 19% (98) working part-time. The jail personnel are involved in direct custody functions, clerical/maintenance activities, and/or the administration of the facilities. Seventy-five percent (396) of these employees are involved in direct custody functions, with titles such as correctional officer, guard, jailer, etc.

Responding agencies report that the daily jail fee charged to other jurisdictions for boarding prisoners averages \$49 per day. The range was \$37 to \$120. The highest fees paid were for juvenile prisoner days. The collective total amount of jail fees received from other jurisdictions in 2006 was \$5,069,941. The total amount of county work release monies collected was \$2,489,733.

County jails often serve a dual function as detention facilities for the unconvicted and as confinement facilities for persons convicted of offenses. The following table analyzes this information collectively:

The average age of a jail facility is 39 years. The range was from 4-years-old to 99-years-old.

The remaining information collected for the jails is presented in tables following the "Jail Definitions". The counties are arranged alphabetically within the following categories: 1) Regional Jail Centers; 2) Full Jail Facilities; 3) Limited Holding Facilities; and 4) Counties Without Jail Facilities. Definitions are provided for clarification.

Jail Definitions

Regional Jail Center – jail facility which houses prisoners from at least one other jurisdiction in addition to the county's own prisoners.

Full Jail Facility – able to house county's own prisoners for extended periods of time (longer than 72 hours).

Limited Holding Facility – limited to holding prisoners for less than 72 hours. Any prisoner who must be incarcerated for more than 72 hours must be transported from a limited holding facility to a regional jail center.

Total Jail Personnel – includes both full and part-time employees involved in jail operations. May include personnel with other responsibilities in the office.

Receive Prisoners From – the counties a regional jail center will receive prisoners from.

Total Prisoner Days – the sum total of days that each prisoner spent in jail. For example, three prisoners for four days equals 12 prisoner days.

Out-Of-County Prisoner Days – number of prisoner days when inmates were held for other jurisdictions, such as neighboring counties and federal agencies.

Daily Fee Charged – price charged per day to other jurisdictions for boarding their prisoners.

Prisoners Received – number of prisoners received by the facility in the year 2006.

Prisoners Taken To – jurisdiction where counties with a limited holding facility or no jail facility take their prisoners.

Total Prisoners Transported – number of prisoners the county had to transport to another jail facility in the year 2006.

Mileage Transporting Prisoners – number of miles traveled by the office transporting prisoners to another facility in the year 2006.

Daily Fee Paid – price paid per day to another jurisdiction for boarding of prisoners.

Total Jail Fees Paid – total dollar amount spent by the office in the year 2006 in jail fees to other jurisdictions.

Total Jail Fees Received – total dollar amount received by regional jail centers from other counties for boarding their prisoners.

Work Release Monies Received – dollar amount of county work release monies collected by the office in the year 2006.



Training

Deputy Advanced Training

Offices were asked how many hours of advanced training are received per deputy, per year on average. Deputies received advanced training in 49 offices (88%). The number of hours ranged from a low of eight to a high of 80 hours. Eighteen offices (32%) reported 20 hours of advanced training per deputy, per year. Seven offices (13%) reported 40 hours.

Twenty-six offices (46%) require a certain number of advanced training hours per year for deputies. The number of hours per year required ranged from a low of 15 hours to a high of 48 hours per year.



Correctional Officer Certification

Forty-two offices (75%) are in favor of a requirement that correctional officers have to be certified.

Jailer Advanced Training

Offices were asked how many hours of advanced training are received per jailer, per year on average. Jailers received advanced training in 24 offices (43%). The number of hours ranged from a low of four to a high of 40 hours. Six offices (11%) reported 10 hours of advanced training per jailer, per year. Five offices (9%) reported 40 hours. Five offices (9%) require a certain number of advanced training hours per year for jailers. Two (4%) offices require 40 hours of advanced training per year for jailers.

Deputy Firearms Qualification

Fifty-one offices (91%) require deputies to qualify with firearms. Yearly qualification is required by 39 offices (70%). Ten offices (18%) require bi-annual qualification, one office (2%) requires quarterly qualification, and one office (2%) requires monthly qualification.

Policies

Pursuit Driving

Offices were asked if they had a written policy on pursuit driving. Forty-seven offices (84%) do have a written policy. Offices that have a written policy on pursuit driving were asked to check the option that best fit their policy. The breakdown is as follows:

- 19 Restricted criteria based on speed/offence, etc.
- 10 Decision left to officer's discretion.
- 12 Decision left to supervisor's discretion.
 - 4 All vehicle pursuits are discouraged.
 - 2 Did not respond.



Use of Deadly Force

Forty-four offices (79%) do have a written policy on use of deadly force.


Violations of Protection/Stalking Orders

Protective Body Armor

Fifteen offices (27%) have a written policy requiring sworn officers to wear protective body armor while 41 offices (73%) do not have a policy. Eleven offices that have a written policy responded that their office provides body armor.






